FUND STRATEGY

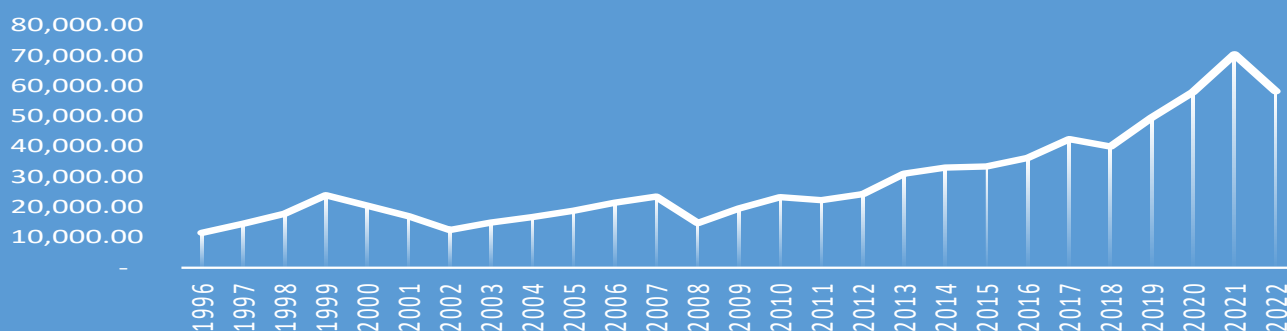

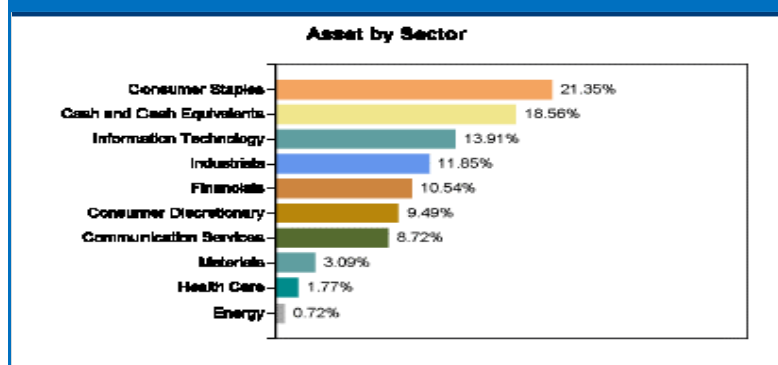

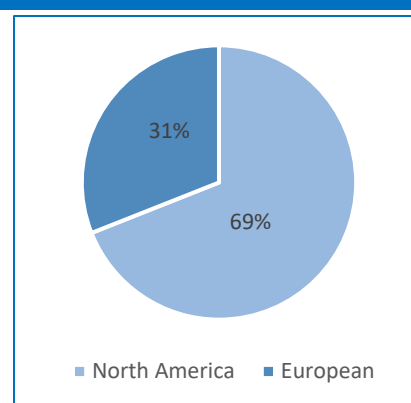
GROWTH OF A \$10,000 INVESTMENT SINCE INCEPTION



SECTOR ALLOCATION



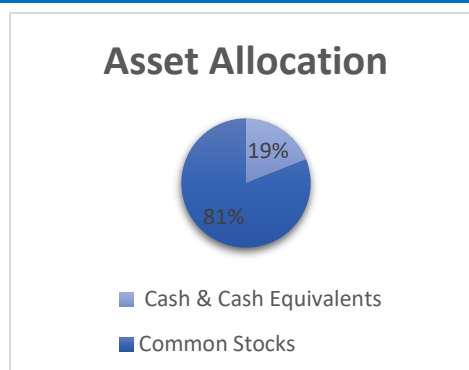
GEOGRAPHIC ALLOCATION
